Oasis for Haiti's Children is a nonprofit corporation incorporated under the laws of the State of Florida, USA. In this Application and Agreement (hereinafter Application) "Oasis for Haiti's Children means the corporation, its trustees, directors, employees, team leaders, and agents. "you" and your" refers to the person signing this Application. The "Host" refers to the Recreational and Educational Center, to which you are assigned to serve, and its employees, and directors.

Oasis for Haiti's Children will make all the necessary arrangements to provide you with the opportunity to work with and learn about local people in the community for which you register. You agree to volunteer your time and talents to the best of your ability following Oasis for Haiti guidelines and policies.

You further agree to the terms outlined in this document.

Service Program Payment Policies

Service Program fees are listed on Oasis for Haiti’s Children’s website at www.OasisForHaitisChildren.org. A \$100 nonrefundable deposit, which is applied toward the Service Program fee, is due with this Application. The balance is due 60 days prior to the scheduled date of arrival. The Service Program fee does not include visas or airfare. You authorize Oasis for Haiti’s Children to use your fee for general operating purposes until the Service Program begins.

Additional Costs are your responsibility

For this international service program, you will need a valid passport. The Service Program fee covers all meals beginning with dinner on the arrival date, lodging, in-country ground transportation, administrative expenses, and work project costs, except those expenses you incur during free time. You are responsible for any additional you may incur during free time and personal time, and for activities that are outside Oasis for Haiti Service Program. Lodging may be shared by two to four people.

Travel Deviations

If you voluntarily deviate from Oasis for Haiti’s Children scheduled itinerary, you may not be able to take the costs of the Service Program as a tax deduction. We recommend that you seek the advice of a tax advisor regarding this matter. (Please inform Oasis for Haiti’s Children of Your travel plans so we can coordinate your arrival and departure with the other members of the team.)
